

Introduction

ReSI Housing adheres to the Housing Ombudsman Complaint Handling Code, ensuring compliance with their complaints handling requirements.

This includes adhering to specified timescales for responses and implementing a two-stage complaint process.

Throughout the reporting year, we received a total of 11 complaints.

In accordance with the new Housing Ombudsman Code, we are sharing our complaint performance metrics and the insights we have gained from these complaints.





Complaints by type

- Out of 7 stage 1 complaints, 7 were upheld.
- Out of 2 stage 2 complaints, 2 were upheld.
- The two most common types of complaints received related to defects and delays in request processing.

Learning from complaints

ReSI Housing

Learning from complaints enables ReSI Housing to foster a positive complaint handling culture, prevent the recurrence of issues, and enhance service delivery.

The complaints reported during the year highlighted the following areas for improvement:

- Delay in request processing: Some customers experienced delays in responses to routine enquiries and requests. In response, we have reviewed internal workflows to improve response times and ensure clearer communication with residents throughout the process.
- Defects: Customers raised concerns about delays in resolving defects post-handover. We worked closely with the developer to ensure that outstanding issues were addressed within the defect liability period, and improved coordination between parties to prevent future delays.

Response from the ReSI Housing Board

ReSI Housing

The Board values customer feedback and recognises complaints as an essential driver of service improvement. While ReSI Housing remains compliant with the Housing Ombudsman's Complaint Handling Code, this year's report highlights key areas for further focus, including delays in request processing and the timely resolution of defects. The Board supports the actions taken to address these issues, such as improved internal workflows and closer collaboration with developers, and will continue to oversee progress to ensure these improvements are embedded and sustained.

The following self-assessment against the Ombudsman's Complaint Handling Code was approved by the Board in May 2024.
